5,548 VOLUNTEER HOURS

The Will County Emergency Management Agency (EMA) had a productive 2022, and it's in great part due to the amazing network of volunteers. With winter weather returning to Northern Illinois this week, the Will County Division of Transportation (WCDOT) is urging drivers to be prepared for snowfall or icy conditions in the coming months.

Preparations should include monitoring weather conditions before driving and ensuring your vehicle is properly stocked with emergency supplies.

During winter weather conditions, WCDOT begins snowplow operations throughout the county to keep our roadways safe. Please keep these five tips in mind when driving with snowplows:

- Slow Down Our snowplows travel around 20 mph or less. Reduce your own vehicle's speed when around snowplows for the safety of you, your passengers, and our snowplow operators.
- Be Alert Snowplows make frequent stops to remove snow and ice buildup. Increase your distance behind snowplows to ensure enough time to avoid a collision should an abrupt stop happen.
- **3. Lights On** If snow is falling, your lights might be the only thing helping others see your vehicle.
- 4. Do Not Pass Most times you're behind a snowplow it's means the road in front of you hasn't been plowed yet. Passing any vehicle during severe weather conditions isn't recommended, especially snowplows.
- 5. Stay Put Traveling during any type of severe weather is not recommended. Try and make every effort to get to a safe place before the storm hits.

The Supervisor of Assessments (SOA) is the starting place for the Will County tax cycle. The SOA office governs every aspect of the property assessment process, serving as the central resource for county residents. They ensure that taxpayers receive fair and equitable assessments by creating accurate maps, maintaining assessment data, and administering property exemptions.

Appeals are processed through the Board of Review, with several key dates approaching for the 2023 tax cycle:

**JAN 25, 2023** | Board of Review final decisions mailed out. Residents who filed a complaint will receive a final decision notice.

**FEB 24, 2023** | Deadline to file a complaint to the Illinois Property Tax Board (www.ptab.illinois.gov).

Turning 65 this year? Do you own and occupy your home as your primary residence? You may be eligible for the Senior Citizen's Homestead Exemption. Please visit the SOA's website (www.willcountysoa.com) to download an application or call the SOA office (815-740-4648) for more information.

Exemption Application Renewals: Renewals will be mailed at the end of April. Residents who applied for exemptions previously are already on the mailing list to receive a renewal application. Residents interested in eligibility for a property tax exemption can visit the SOA's website for more information.
