Earlier this year, I shared with you that my office has been working with the newly formed Will County Community Mental Health Board to ensure that they have the necessary resources to accomplish their important mission. The Board was formed after Will County voters approved the creation of a new levy dedicated to directly funding local mental health services. Voters clearly saw that there was a need in our community for increased mental health services, including for substance use, disability services, and veteran care.

I'm happy to share with you now that the Will County Board has approved a budget for the Community Mental Health Board, empowering a \$10 Million-dollar investment into local mental health resources. This funding will be utilized to award grants to community organizations throughout the county who are near a breaking point as the demand for their services have increased in recent years. We saw this need first-hand when we opened applications for our American Rescue Plan Act funding. Although we only had \$16 Million-dollars available for mental health services, we received \$94 Million-dollars in request from local organizations.

Ensuring access to quality mental health services has been a top priority for Will County government over the last two years. This increase in funding for local services will offer relief for our hard-working community organizations and the thousands of residents who are in need of support. I look forward to continuing to work with the new board as they identify how best to allocate this new funding.

## **Barn Cat Adoption Program**

The Will County Animal Control Department has launched a new program with the intention of placing adult feral and semi-feral cats on agricultural properties in and around Will County. The Barn Cat Adoption Program, also referred to as "Whiskers at Work," is open to anyone who lives or works on agricultural-zoned property. It provides a home for cats who would not traditionally do well in a household pet setting and provides year-round rodent and pest control support for farm owners.



According to Will County Animal Control Administrator Anna Payton, the cats that are part of the Whiskers at Work program wouldn't make good 'indoor cats' in traditional household settings: "Most of these cats are not used to contact with humans and would not be happy as house cats. With this program, residents are allowing them to live their best lives, where they can serve a fulfilling purpose hunting invasive barn rodents in our agricultural areas."

Adoption fees are waived by Will County Animal Control once an applicant is accepted through the Whiskers at Work program. Whiskers at Work's barn cats are spayed/neutered, up-to-date on vaccines, tested for Feluk/FIV, microchipped, and ear-notched.

In order to be eligible, the person requesting to be considered for the program must live or work on agricultural-zoned property and be the owner of the property the barn cat will be deployed.
