# FREE WORKSHOP ON BEP/EEC CERTIFICATION

## Business Owners: Expand Your Opportunities!

Local business owners are invited to attend a free in-person workshop to learn about the Illinois Business Enterprise Program (BEP) and opportunities to pursue projects as an Equity Eligible Contractor (EEC).

The workshop is hosted as a collaboration between the Will County Executive Office, Joliet Junior College (JJC) Entrepreneur & Business Center, the Will County Center for Economic Development, and the State of Illinois. The half-day session will offer business owners an opportunity to attend a session on either topic on Wednesday, February 25th at the JJC City Center, with the BEP session being held from 9:30 a.m. to 11:30 a.m. and the EEC session being held from 12:00 p.m. until 2:00 p.m.

Business owners will have an opportunity to learn about expanded contract opportunities as a BEP- or EEC-certified business. The workshop will share how certification positions businesses for government/utility contracts, supplier diversity opportunities, and clean-energy projects. The recommended audience includes small business owners, contractors, the trades, clean-energy businesses, or entrepreneurs seeking growth opportunities.

## Will County Accepting “Adopt-A-Highway” Applications!

Is your organization looking for your next service project? The Will County Division of Transportation's Adopt-A-Highway program is an opportunity for local groups to help create a cleaner environment by volunteering to pick up litter along the county highway system.

The Adopt-A-Highway program is an education program designed to encourage people to stop littering. It is a roadside cleanup program that will give a better first impression of our county to visitors and tourists.

Each volunteer group is responsible for a two-mile section of highway and agrees to remove litter a minimum of four times a year over a two-year period. Will County DOT will erect permanent signs identifying the adopting group and will provide safety vests, trash bags, temporary warning signs, and initial safety training.

# SAFE & CLEAN DRINKING WATER

## Latest Consolidation to Improve Water Services

A recently approved local government consolidation will address years of water quality issues, system breaks, and sewage back-ups in the Preston Heights neighborhood and surrounding areas in unincorporated Joliet Township. This follows final approval of an intergovernmental agreement between Will County, the City of Joliet, and the Southeast Joliet Sanitary District (SEJSD) that will dissolve the district and transfer services to the City.

Under the agreement, the City of Joliet will take responsibility for water and sewer service in the area and immediately begin repairs to the system. Will County has committed funding for much-needed upgrades for the existing system over a ten-year period to ensure stable access to safe drinking water for residents, leveraging a combination of federal funding sources.

“This has been a collaborative process to address water and sewer maintenance issues that have negatively impacted more than 850 households in unincorporated Will County for years. Residents deserve access to clean drinking water and infrastructure that works for them. I’m grateful to the City of Joliet and the leaders in the community who worked with the county to make this transition a reality to better serve our residents.”

The agreement is the third unit of local government that has consolidated within Will County in recent years, creating efficiencies and improved services for residents. These include the consolidation of the Romeoville Mosquito Abatement District and East Moreland Street Lighting District.
